Regular Membership

Regular Membership is available to exempt positions under contract directly or indirectly with a Local Government or a First Nations. Members must have some managerial or supervisory duties or responsibilities. A person may be granted Regular Membership status by application to the Board if they hold a unionized managerial position and are not in an active representative role in the union or its executive. LGMA staff can provide the application at office@lgma.ca

Life Member

Life Membership is granted by the Board of Directors.

Affiliate Member

Affiliate members are any persons or organizations with an interest in local government. Affiliate member categories are noted in [LGMA policy](#). Affiliate members must apply to the Board of Directors. LGMA staff can provide the application at office@lgma.ca. A person granted an affiliate membership is **not** entitled to vote at general meetings or to be a director.

Retired Member

Retired membership is also available to individuals who were a member of the Association immediately prior to retirement or is in receipt of a municipal retirement pension or equivalent and is retired from regular full time employment. No application review by the Board is required.

Student Member

Student membership is also available to students enrolled in a full-time course of studies in an accredited Canadian post-secondary educational institution. No application review by the Board is required.
